# **Hydrology Study**

In January, Dian and Rosemary were invited to attend a meeting of the reconvened Alouette Rivers

Management Task Force to review preliminary results and a presentation by Northwest Hydraulics. Final reporting and presentation to council will not occur until June.

- Dian reminded Andrew that AVA has been told that many tasks (dredging at the 224<sup>th</sup> St Bridge in particular) are contingent on this study, and what would the next steps be in regard to that.
- The District is expected to finalize the report in March
- Ken Stewart suggested an update meeting in March Rosemary & Dian will nag Andrew to make sure it happens.


There is progress being made but we are not happy that it is taking so long. Given that council will not see the final report until June, it seems unlikely that much if any mitigation will happen this year. We are particularly concerned that the problematic constriction in the 2 bridges (Edge and 224<sup>th</sup>) will not be addressed.

# **Traffic Calming & Recreational Roadway Proposal**

Somebody at district hall is listening. District engineering staff have been measuring the streets and we understand that they will use these measurement to determine if our proposal is feasible. We are encouraged but it is now even more important that we keep the pressure on the district to implement the proposal. In a recent meeting with district staff (traffic calming department) we were told that 132nd Avenue is considered to be an arterial road. Fact is, if we don't accomplish our Roadway objectives, there is little that they can do to calm the area because of this designation. We can expect a lot more traffic and further erosion of the livability of our neighborhood. (cont. p2)

Nona, Bruce and Terri attended a meeting on April 4th with Richard Wong of the Engineering Department, and Bruce McLeod of Parks and Leisure Services. We were given large maps of the roadway showing property lines and road allowances, and they agreed to join us for a "walk about" to see where it would be possible to accommodate a multi-use pathway along existing road allowances. We

will be out shortly for our own "walk about" to prepare for the district. If you see us out front, please join us, or give us your opinions and creative ideas. We stressed to municipal staff that esthetics are a big part of this project, we need to ensure the country ambience is preserved and enhanced.

### North Alouette Greenway Bridge Crossing
